# Summary of findings

#### Overall summary

Woodlands Care Centre is a care home providing personal and nursing care to older people. At the time of our visit, there were 95 people living in the service. The service is divided into five separate units, Dove, Byron, Tennyson, Coleridge and Wordsworth. Each unit consists of lounge areas, dining areas, bathrooms and single bedrooms with en-suite facilities.

We found the following examples of good practice.

The service was only receiving essential visitors at the time of our inspection. Any person entering the building undertook a rapid flow test (RFT), which gives a COVID-19 test result within 30 minutes. Visitors also had their temperature taken, completed a health questionnaire and wore full personal protective equipment (PPE).

People were supported to keep in touch with friends and relatives through video calling. This included one person being supported to take part in a close relatives funeral via a video call.

The manager told us that they had changed systems within the service to reduce the risk of spread of infection. For example, staff used different entrances into the building to minimise any cross infection.

Whole home testing was carried out on both people and staff.

Cleaning of the home, including frequently touched surfaces, had increased to reduce the risk of transmission of infection. The manager had purchased fogging machines to support the increased scheduled deep cleaning of the building.

Policies in place had been updated with COVID-19 information, which meant that actions to reduce the risk of transmission were taken.

#### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe and the service was compliant with IPC measures.
