Summary of findings

Overall summary

Eastcliffe is a care home that provides personal care for up to 10 people with learning disabilities or autistic spectrum disorder. At the time of the inspection there were 10 people living in the home.

We found the following examples of good practice.

- Systems were in place to help prevent people, staff and visitors from catching or spreading infection.
- The environment was clean. Additional cleaning was taking place, including of frequently touched surfaces.
- Staff wore appropriate PPE and there were sufficient supplies. The provider carried out weekly checks to ensure the service always had enough PPE for staff to access. PPE stations were placed around the home for ease of access to staff.
- Staff had undertaken training in putting on and taking off PPE and other COVID-19 related training.
- People and their relatives were supported to keep in contact using a range of technology as well as visits to the home, in line with government guidance. There was also an covered outdoor area for relatives to visit with people, if preferred.
- People and staff participated in a regular testing programme, in line with government guidance.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at how services manage infection control and visiting arrangements. This was a targeted inspection looking at the infection prevention and control measures the provider had in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 17 February 2022 and was announced. We gave the service short notice of the inspection.

Is the service safe?

Our findings

Staffing

- The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures.

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- Staff supported people to receive visits from their relatives in line with government guidance. People could receive visits in their rooms, well ventilated communal areas or in a seated, sheltered garden area.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

- The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
