Summary of findings

Overall summary

Chelston Park Nursing and Residential Home provides accommodation and nursing care for a maximum of 86 older adults, some of whom may be living with dementia. There are two separate buildings on site; Chelston Park and Chelston Gardens.

Chelston Park provides accommodation with nursing and residential care for a maximum of 36 people in 31 rooms; five of the rooms are doubles so can accommodate two people if they choose to share.

Chelston Gardens is a purpose-built home which is divided into four distinct units over two floors. Chelston Gardens provides accommodation with nursing care for up to 50 older people who are living with dementia.

There are large, well maintained grounds with parking.

At the time of inspection, there were 62 people living at the service; 20 in Chelston Park and 42 people in Chelston Gardens.

We found the following examples of good practice.

When new people were admitted to the service, they were accommodated in a separate wing of the home. This helped to reduce the risks of any possible cross-infections.

There were two visitor rooms, one in each building which had been adapted to ensure visitors were able to enter from the garden and then meet their relative with a screen between them to reduce the risks of infection.

An external Infection prevention and control consultant had conducted an audit of the service and produced a report. This had provided additional assurance and supported the service to make improvements.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.
