## Summary of findings

#### Overall summary

Stanley Park is a 'care home.' The service provides accommodation for up to 71 people with personal care needs, some of whom were living with dementia. On the day of our inspection 52 people lived at the service.

We found the following examples of good practice.

Staff had completed IPC training and used PPE correctly. This helped prevent the spread of infection. Staff could access advice and support if needed. Some staff had been identified as IPC champions. They completed additional training and attended external meetings, they used their expertise to help promote good practice.

The home was clean and tidy throughout. Staff maintained enhanced cleaning practices to help manage infections.

There were no restrictions on visiting the home. Although wearing a face mask was encouraged in communal areas.

#### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 12 September 2022 and was unannounced.
