Summary of findings

Overall summary

Lyncroft Care Home is a purpose built two-storey residential care home providing accommodation and personal care for up to 52 older people and people living with dementia. At the time of our inspection there were 50 people using the service.

We found the following examples of good practice.

Staff followed the providers robust infection prevention and control procedures. This included checking their temperature upon commencing each shift and wearing appropriate personal protective equipment (PPE). There were adequate stations for staff to change their PPE. Staff had completed training in infection control and the correct use off PPE. Competency checks and daily visual checks were completed to ensure best practice was followed.

Visitors entered the home using a dedicated entrance to visit their friends and family. All visits were booked in advance. The visiting room was partitioned by a screen to keep people safe, allowing families and friends to meet. The room was thoroughly cleaned after each visit. Visitors were required to take a COVID-19 test and wait for the results before commencing their visit.

Staff and service users took part in the national COVID-19 testing programme for care homes. Individual risk assessments were completed to keep people and staff safe. The home had two floors that were treated as separate zones. Staff only worked in their allocated zone, in order to reduce movement across the home and any subsequent risk of cross contamination and transmission of infection.

The building looked clean and free from clutter. Appropriate cleaning products were used, to ensured good infection control was maintained. Cleaning schedules ensured frequently touched areas were sanitised regularly.

Any updates or changes to guidance, in relation to COVID-19, were communicated to both staff and people living in the home. The registered manager confirmed that they had received a good level of support and information from the local authority. Staff and residents had received their vaccinations.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.
