Summary of findings

Overall summary

Prince Alfred Residential Care Home provides care and support for up to 50 people. At the time of the inspection visit there were 33 people living there. Communal lounges and dinning areas are situated on the ground floor and bedrooms are located on the upper two floors and can be accessed by stairs and a passenger lift.

We found the following examples of good practice

Visits were restricted to essential visitors only and they were carried out safely. Arrangements were in place to safely facilitate visits for people receiving end of life care. A 'visiting pod' was in the process if being built outside the main building to provide a safe space for family visits.

Staff followed shielding and social distancing rules and encouraged people to maintain social distancing. Furniture in communal areas had been rearranged to help people to maintain social distancing.

No person had been admitted to the service during a recent COVID-19 outbreak, however safe procedures were in place for admitting people into the service.

The right standard of personal protective equipment (PPE) was in good supply and PPE stations were located across the service. Staff completed training and underwent regular checks on their competency around the safe use of PPE. Staff used and disposed of PPE correctly.

COVID-19 testing was available to people using the service and staff. The frequency of testing was in line with current guidance.

Staff reassured people throughout the pandemic and provided them with the support they needed to maintain regular contact with family and friends through the use of technology.
