Summary of findings

Overall summary

Brighstone Grange is a care home registered to provide accommodation for up to 23 older people, some of whom were living with dementia. At the time of our inspection there were 19 people living in the home.

We found the following examples of good practice.

People were supported by staff who understood how to keep them safe and support their individual needs and wellbeing.

Staff were supported by the provider who had recognised the impact of the pandemic on their wellbeing and had arranged for an external professional to provide individual support for staff if they wanted it.

The provider was following best practice guidance to minimise the risks of visitors to the home from COVID-19. There was a robust process in place to ensure visitors were asked to consent to a lateral flow test (LFT), complete a health questionnaire and have their temperatures Taken, prior to entering the home. This reduced risks to people living in the home.

Staff had received IPC training and there was an up to date infection prevention and control (IPC) policy. Staff were regularly updated with any changes to government guidance and procedures to follow so they could keep themselves, people and visitors safe.

Staff were seen to be correctly wearing personal protective equipment (PPE).

The service was accessing regular testing for both staff and people living in the home.

People were comfortable with staff and visitors wearing masks and understood it was to prevent the spreading of infection. People were encouraged to socially distance, whilst being mindful of the need for a homely environment.

Brighstone Grange Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at how services manage infection control and visiting arrangements. This was a targeted inspection looking at the infection prevention and control measures the provider had in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 14 February 2022 and was announced. We gave the service 2 days' notice of the inspection.

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.

• We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.

• We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.

• We were assured that the provider's infection prevention and control policy was up to date.

• People's relatives were able to visit by booking in advance, so that staff could safely support visits, and the areas could be cleaned prior to and following the visit. The provider had safe processes in place to ensure visits for people living in the home were in accordance with the current government guidance and information about this was displayed for visitors to understand.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
