Summary of findings

Overall summary

Laburnum Lodge is situated in the Breightmet area of Bolton. The service is owned by Bolton Council, is close to local amenities and is on a local bus route. The service provides short stay intermediate care and support for 32 people. The aim of the service is to help people to return to their own home or move in to other care settings.

We found the following examples of good practice:

- There was an excellent procedure in place at the reception area, which was clearly communicated to professional visitors. This helped ensure people were aware of the current requirements and helped minimise the spread of any infection.
- The service had developed good relationships with people's family members and kept in regular contact with them to ensure they were fully informed of all current guidance.
- The service had followed guidance well and managed to contain outbreaks and learn lessons to inform any further issues. Staff responded calmly to any potential issues and had gained a better understanding of infection prevention and control.
- Joint working with clinicians had worked well and a mutual respect and acknowledgement of strengths and skills was evident.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a review of infection control and prevention measures in care homes.

The service had been identified for use by the Local Authority as a designated care setting in response to the Winter Plan for people discharged from hospital with a positive Covid-19 status. The inspection was to ensure that the service was compliant with infection control and prevention measures.

This inspection took place on 3 November 2020 and was announced.
