# Summary of findings

#### **Overall summary**

Ashbourne Care Home provides accommodation and personal care to a maximum of 38 older people, some of whom lived with physical conditions and/or dementia. At the time of our inspection 31 people lived at the home.

We found the following examples of good practice.

•An enclosed pod was used to enable safer visiting. Visits by friends and relatives were enabled on an appointment only basis. Protocols for visiting were in place to minimise the risk of infection being acquired and transmitted.

•Adequate stocks of Personal Protective Equipment (PPE) were available for staff, family members and professional visitors to the home.

•People used video and telephone methods to maintain contact with family and friends. Regular newsletters were distributed to people and relatives to keep them informed of the latest updates.

• Staff worked closely with infection control professionals to minimise the potential of infection outbreaks occurring in the home.

• Regular COVID-19 testing of people and staff was undertaken to ensure infection outbreaks were identified and controlled.

• The environment was clean. Staff carried out touch point cleaning and deep cleans throughout each day to ensure the risk of infection and transmission was minimised.

# Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.
