# Summary of findings

## Overall summary

Victoria Mews is a care home and provides personal care to a maximum of 30 younger adults, older adults and people living with dementia. At the time of our visit 26 people lived at the home.

We found the following examples of good practice.

- A visitor code of conduct was in place. The code detailed the requirements of all visitors to the home during the pandemic. On arrival at the home the temperature of visitors was recorded, and a risk assessment was completed to ensure visits could be completed safely.
- The registered manager had shared their experiences of how the pandemic had impacted on their service with Healthwatch Coventry. A report of findings had been written in September 2020 to share learning across the sector.
- Staff had been supported in a variety of ways to help them understand and cope during the pandemic. The support including signposting to a confidential helpline for advice.
- The registered manager and deputy manager were 'Mental health first aiders.' This meant they were trained to spot signs of mental ill health of their staff and take action to support positive wellbeing.
- Staff wore masks with clear panels to aid communication. This meant people who had hearing impairments could read their lips. Guidance had also been implemented to help staff communicate with people whilst they were wearing a mask.
- Cleaning schedules had been increased and additional audits had been implemented to monitor cleanliness and staff compliance with the provider's infection control policy.
