### Summary of findings

### Overall summary

Woodway House is a residential care home providing accommodation and personal care to up to 32 people. At the time of our inspection there were 25 people living at the home. Accommodation is provided over two floors with communal lounges and dining areas.

We found the following examples of good practice

- Safe staffing levels were maintained at the service. All staff had completed external health service led training in relation to infection prevention and control (IPC) and correct use of personal protective equipment (PPE), including donning and doffing. Regular refresher training sessions were facilitated by the registered manager who also completed regular competency checks.
- Activities were encouraged socially distanced to support people to engage in meaningful activities and to minimise impact on their wellbeing. Activities were repeated throughout the week to allow equal access for people.
- Cleaning schedules were in place and frequently audited to ensure the equipment and premises were clean. High touch areas were cleaned at least three times every 24 hours with appropriate cleaning products.
- Policies, procedures and risk assessments in relation to COVID-19 were up to date and reviewed regularly.

**Detailed findings** 

### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 26 January 2022 and was unannounced.

### Our findings

#### Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures.

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- The service had clear visiting protocols in place and information was provided to all visitors to ensure they were familiar with the service's IPC procedures and PPE policy. The service was meeting the government guidelines in relation to visiting.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.
