## Summary of findings

#### Overall summary

Jane House is a care home providing accommodation and personal care for up to five people with a learning disability. The home was fully occupied at the time of our inspection.

We found the following examples of good practice.

On arrival to the home, essential visitors were asked to complete and sign a screening form regarding COVID-19 symptoms and were asked to wash and sanitiser their hands, put on a facemask and have their temperature checked. Visitors were also asked to confirm they had their COVID-19 vaccinations or evidence of exemption. This assisted in identifying visitors who may be at a higher risk of transmitting an infection to people living in the home.

People and staff received regular COVID-19 tests.

People were provided with accessible information about COVID-19 and how to keep safe.

Staff had taken steps to support people in maintaining contact and visits with family and friends.

The home was clean and well ventilated.

There was prominent signage and instructions explaining how to meet infection prevention and control standards.

Staff were observed wearing appropriate PPE.

The service had robust infection control auditing systems.

**Detailed findings** 

#### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 13 January 2022 and was announced. We gave the service 24 hours' notice of the inspection.

### Our findings

#### Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The service was meeting the requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
