Summary of findings

Overall summary

2, 3 and 4 Nightingale Close provides accommodation and personal care for up to 18 people with a learning disability. At the time of the inspection, 15 people were living at the service. These properties was in keeping with the other houses in the area.

We found the following examples of good practice.

The premises were clean and hygienic. Cleaning schedules were in place, including for touch points.

Personal Protective Equipment (PPE) and appropriate handwashing and sanitising facilities were available to staff.

The staff and residents were taking part in regular COVID-19 testing and had been given the COVID-19 vaccine. If people lacked capacity, the best interest decisions had been taken to inform if people should have the vaccination.

Some staff had refused to accept the COVID-19 vaccination and the registered provider was providing information workshops to these staff to encourage up take.

Staff had been trained in infection prevention control (IPC) and COVID-19. Pictorial guidance is displayed.

People were supported to stay in touch with their families through visits that met current government guidelines.

Plans were in place which looked at how the service could cohort staff and zone the service effectively if there was an infection or an outbreak in the future.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 23 June 2021 and was announced.
