## Summary of findings

#### Overall summary

Feng Shui House Care Home is a residential care home providing personal care to 17 people aged 65 and over at the time of the inspection. The service is registered to support up to 20 people.

We found the following examples of good practice.

People were cared for in a clean and homely environment. Infection control systems and audits ensured a clean environment people. Visiting at Feng Shui House Care Home was restricted. Visitors were required to follow best practice guidance and wear appropriate PPE. Their visiting policy and restrictions had been discussed with people, their families and friends.

We observed all staff had access to and wore personal protective equipment (PPE). They were able to share best practice on the putting on and taking off PPE. We observed PPE was available at the entrance and on all floors of the home. The home was registered to regularly test staff and people for the COVID-19 infection. Staff deployment was structured to ensure people were safe. The registered manager reviewed staff levels as people's needs and occupancy levels changed.
