Summary of findings

Overall summary

Conifers Nursing Home is a nursing and residential home providing accommodation and personal care for up to 33 people in one purpose-built building over two floors. There were 13 people living at the home at the time of our inspection.

We found the following examples of good practice.

Clear guidance, an explanation and apology about restrictions were displayed at the entrance to the home. All visitors have lateral flow test undertaken. Temperatures are checked, hand sanitiser is available and PPE stocks.

In line with government guidance, the home had recently commenced in-home visits. There was a clear pre-booking system with 10 appointments available throughout the day. Scheduled deep cleaning was undertaken between each visit. The home had dedicated one room, close to an alternative entrance to be used just for these visits. Stocks of PPE were situated next to this.

The home also supported visiting through a purpose-built pod and window visits. To support people to communicate during these visits baby monitors were used to aid listening. There was a gazebo to shelter relatives during window visits. Relatives were well-supported to visit people at the end of their life.

Additional cleaning had been put in place. The registered manager had good oversight of cleaning and regular checks about infection prevention and control (IPC) processes were undertaken.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.
