Summary of findings

Overall summary

Claremont Lodge Care Home is a care home providing personal and nursing care for up to 35 people. There were 29 older people living at the service when we inspected. The service supports people with various health conditions, including dementia and sensory impairment.

We found the following examples of good practice.

Visitors were welcomed to the home using an appointment system. The number of visits per day were overseen by the management team. A visitor area had been set up with screens, personal protective equipment and social distancing. Extra screens were placed to give people and their visitors privacy.

People had been driven to local beauty spots and local places of interest to support their well-being. Entertainment had taken place in the garden. For example a singer coming to perform for people on D-Day.

Staff had personal hand sanitisers available which clipped to their uniforms. Staff also carried a hands free door opener clip to reduce the need to touch door handles and reduce the risk of spreading infection.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.

This inspection took place on 19 October 2020 and was announced. The service was selected to take part in this thematic review which is seeking to identify examples of good practice in infection prevention and control.
