## Summary of findings

### **Overall summary**

Victoria Park Care Home (Ilkeston) is a residential care home providing personal and nursing care to 18 people aged 65 and over at the time of the inspection. The service can support up to 39 people in one adapted building across two floors.

We found the following examples of good practice.

Some people using the service were supported with essential care givers to enable regular visiting to be completed. Visiting procedures were in place in line with government guidelines.

When new admissions were placed in the home there was a process in place to ensure safety was considered and care plans completed. Individual risk assessments were in place to consider the impact of Covid-19, on individual health conditions and regarding the testing and vaccinations.

The service was cleaned by staff who had cleaning schedules for all areas of the home and high touch areas. Cleaning products had been changed to ensure they were suitable to reduce the risks associated with COVID-19.

Staff participated in the testing and vaccination programme. We observed staff wearing the correct PPE throughout our inspection.

# Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at how services manage infection control and visiting arrangements. This was a targeted inspection looking at the infection prevention and control measures the provider had in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 22 February 2022 and was unannounced.

- The provider was following the government guidance in relation to visitors. Many people using the service had essential care givers. Technology was also used to enable contact through facetime or using the telephone to make contact with family and friend.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.

We have also signposted the provider to resources to develop their approach.
