Summary of findings

Overall summary

Parklands Care Home accommodates 42 people with personal care needs in one adapted building. Some of the people were living with dementia. On the day of our inspection there were 31 people using the service.

We found the following examples of good practice.

Checks were made on visitors to the service including their Covid-19 test results. Vaccination status was checked for visiting professionals.

The environment was clean and additional cleaning was taking place for surfaces that were touched frequently, such as handrails.

There was enough PPE. There was clear signage on the correct use of PPE and handwashing techniques, and staff had received training in infection prevention and control.

The home had an infection prevention and control lead who was responsible for sharing best practice with other staff.

Staff gave positive feedback about the support they were offered during the pandemic. The management had worked with other agencies to promote staff well-being.

Staff told us people were supported to have contact with, and visits from, relatives in-line with government guidance.

Parklands Care Home Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 7 February 2022 and was unannounced.

Our findings

Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.

• We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.

• We were somewhat assured that the provider's infection prevention and control policy was up to date. The provider had a policy statement relating to Covid-19 and current guidance, but their IPC policy had not been updated to reflect this.

• People received visits from friends and family members, and where this happened it followed the current guidance.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.

We have also signposted the provider to resources to develop their approach.
