# Summary of findings

## Overall summary

Rosegarland Care Home is a residential care home in Bradford. The home provides accommodation and personal care for older people and people living with dementia. The service is registered to accommodate up to 18 people. At the time of inspection there were 10 people living at the home.

We found the following examples of good practice.

- Visiting to the home was managed safely. The registered manager has ensured visits are spaced out to avoid potential infection transmission. Visitors complete a lateral flow test and fill out a questionnaire to ensure they are symptom free and have had no contact with people who have tested positive for COVID-19.
- The registered manager effectively seeks the guidance of the Local Authority infection prevention and control team. This enabled them to support visitors to the home to celebrate people's birthdays safely.
- During the COVID-19 outbreak an area of the home was sectioned off to enable people with the virus to be isolated.

## **Detailed findings**

### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.

This inspection took place on 19 July 2021 and was announced.

# Is the service safe?

## Our findings

How well are people protected by the prevention and control of infection?

- We were assured the provider was preventing visitors from catching and spreading infections.
- We were assured the provider was meeting shielding and social distancing rules.
- We were assured the provider was admitting people safely to the service.
- We were assured the provider was using PPE effectively and safely.
- We were assured the provider was accessing testing for people using the service and staff.
- We were somewhat assured the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured the provider's infection prevention and control policy was up to date.
- We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.

The laundry area of the home required improvement around infection prevention and control measures. This included consideration of handling laundry, storing laundry, the availability of PPE, lever taps and a clinical waste bin. Consideration was required around recruitment of domestic staff to ensure hygiene standards could be maintained without impacting on care.

We have also signposted the provider to resources to develop their approach.
