Summary of findings

Overall summary

Forest Dene Residential Care Home is a 'care home'. People in care homes receive accommodation and nursing or personal care as single package under one contractual agreement. CQC regulates both the premises and the care provided. The home is registered to provide support to a maximum of 40 people. At the time of the inspection there were 33 people using the service. Care was provided on three floors.

We found the following examples of good practice.

There were infection prevention and control systems in place. The premises were clean and tidy. Staff had attended infection prevention and control training and how to use personal protective equipment [PPE]. There was enough PPE and the manager had no issues obtaining it. Regular COVID-19 tests were undertaken including when people came to the service. Staff followed latest government guidance to manage the impact of the pandemic. The service worked well with local healthcare professionals in sharing information and communicating information about matters related to IPC. Regular audits were undertaken to ensure any gaps were identified and actions taken to mitigate the risk of cross infections.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 27 January 2022 and was announced. We gave the service 24 hours' notice of the inspection.

Is the service safe?

Our findings

Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures.

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- The provider followed latest government guidance on visiting care homes. They consulted people and relatives about visiting and made arrangements for people to see their loved ones in person or virtually using electronic devices.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The service was meeting the requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
