Summary of findings

Overall summary

Birchy Hill Care Home provides care for up to 70 people who require residential or nursing care. The service cares for people with a variety of needs, including complex needs associated with chronic and acute medical conditions and provides specialised dementia care. Accommodation for people is arranged over three floors and five living units. There is a well maintained sensory garden that provides safe, accessible areas for people to enjoy.

We found the following examples of good practice.

- •□Visits to the home were by appointment only to manage numbers. The provider policy stated one person at a time per family allowed to visit. There was ample outside space to enable socially distanced visits within each separate area of the garden in proximity to each individual unit. People were also able to keep in touch with friends and family via Skype. Computers were made available within the home with instructions and support on how to use them.
- •□Each of the five units was treated as a separate entity, described by the registered manager as five 'homes' within the home. Staff only worked on one unit, which included cleaning staff, to reduce risks of cross infection between units. Staff took breaks individually and in designated areas, including outdoors in the garden.
- Uulnerable staff were risk assessed and supported to manage any health conditions or to shield if required. Staff were asked if they would like to be re-deployed to non-contact duties to reduce risks.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.

This inspection took place on 18 August 2020 and was announced. The service was selected to take part in this thematic review which is seeking to identify examples of good practice in infection prevention and control.
