## Summary of findings

#### Overall summary

Belvoir Vale Care Home provides accommodation and personal care for up to 56 people in three separate buildings. On the day of our inspection, 48 people were living at the service.

We found the following examples of good practice.

The provider ensured all visitors to the home provided evidence of a negative LFT result. Professionals were required to provide proof of COVID-19 vaccinations. An electronic monitoring system reminded visitors to wear a mask and also took their temperature prior to entering the home. People had access to visitors when they wanted them. Essential care givers were permitted further access to the home to support staff with caring for their relatives.

There were ample supplies of PPE throughout the home. Staff wore PPE when required. PPE stations were placed around the home for easy access. Used PPE was disposed of safely. Efforts had been made to encourage social distancing. For example, dining tables were limited to three people and chairs in communal areas had been separated. Safe isolation procedures were in place. The layout of the home with three separate buildings meant access to some parts of the home could be restricted, reducing the risk of the spread of infection.

The domestic staff had cleaning schedules in place. The quality of their work was reviewed via regular auditing. We observed the home was visibly clean and tidy.

People were admitted to the home in a way that reduced the risk of the spread of COVID-19. All new admissions had to meet required vaccination status and negative LFT result before entry was granted to the home.

Increased support from staff was in place to support people living with dementia to maintain social distancing. Posters were placed around the home offering guidance and information for people and staff advising them how to spot the signs of COVID-19 and to help to reduce the risk of spreading it.

All staff and people living at the home were tested regularly and in accordance with government guidelines. The provider had ensured staff were fully vaccinated in order for them to carry out their role.

There were enough staff to support people safely and to cover any staff holidays, sickness and COVID-19 isolation. Agency staff had been used where needed.

The provider considered staff member's wellbeing. A variety of initiatives were in place to thank staff for their support.

Occasionally, non-care staff have supported care staff with their roles, for instance during busy periods or if

a staff member was off work sick. Regular COVID-19, outbreak and other related audits were carried out to help identify any areas of concern. Action plans were in place and reviewed.

# Belvoir Vale Care Home

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 1 March 2022 and was announced. We gave the provider notice of the inspection.

## Our findings

Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.

• We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.

• We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.

• We were assured that the provider's infection prevention and control policy was up to date.

• The registered manager ensured people were able to see their visitors in such a way that did not increase the risk of the spread of infection throughout the home. People's individual needs had been assessed, and the impact of not seeing visitors would have on their wellbeing. Action had been taken by the registered manager to the reduce the risk of people experiencing social isolation and loneliness.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
