Why we carried out this inspection

We undertook this inspection as there were some concerns raseid in the safe domain relating to the management of medicines. We only inspected safe, effective and well-led as part of this inspection.

How we carried out the inspection

Throughout the pandemic CQC has continued to regulate and respond to risk. However, taking into account the circumstances arising as a result of the pandemic, and in order to reduce risk, we have conducted our inspections differently.

This inspection was carried out in a way which enabled us to spend a minimum amount of time on site. This was with consent from the provider and in line with all data protection and information governance requirements.

This included:

- Conducting staff interviews by telephone and using video conferencing
- Completing clinical searches on the practice's patient records system and discussing findings with the provider
- · Reviewing patient records to identify issues and clarify actions taken by the provider
- Requesting evidence from the provider
- · Gaining feedback from staff using staff questionnaires
- A shorter site visit

We have rated this practice as good for providing safe, effective and well-led services because:

Whilst we found no breaches of regulations, the provider **should**:

- Embedded the new templates to ensure medication reviews are fully documented.
- Continue to regularly audit patients prescribed high risk medicines to ensure they are being monitored in a timely manner and in line with guidance.
- Continue to work with patients to encourage the uptake of cervical screening.
- Embedded the management oversight of the workflow system.

Our inspection team

Our inspection team was led by a CQC lead inspector who spoke with staff using video conferencing facilities and undertook a site visit. The team included a GP specialist advisor who spoke with staff using video conferencing facilities and completed clinical searches and records reviews without visiting the location.

Background to Donneybrook Medical Centre

Donneybrook Medical Centre is located in Hyde at:

The provider is registered with CQC to deliver the Regulated Activities; diagnostic and screening procedures, maternity and midwifery services, family planning, treatment of disease, disorder or injury and surgical procedures.

The practice is situated within the Greater Manchester Integrated Care Systems (ICS) - Tameside and delivers General Medical Services (GMS) to a patient population of about 8421. This is part of a contract held with NHS England.

The practice is part of a wider network of GP practices (Hyde Primary Care Network (PCN)) and is part of the Tameside locality of the Greater Manchester Integrated Care Board. PCNs work together with community, mental health, social care, pharmacy, hospital and voluntary services in their local area.

Information published by Public Health England shows that deprivation within the practice population group is in the third decile (3 of 10). The lower the decile, the more deprived the practice population is relative to others.

According to the latest available data, the ethnic make-up of the practice area is 10% Asian, 87% White and 3% other. The age distribution of the practice population differs from that of local and national averages, for example, there are more older patients (20.4%) registered at the practice compared to England average (17.7%). They also had a higher prevalence of patients with diabeties, with 12% of patients compared to 7% England average and a higher prevalence of hypertention, with 19% of patients compared to 14% England average.

There is a team of three GP partners a salaried GP and Specialist Trainee. There was a nurse practitioner, two practice nurses, two assistant practitioners and a health care assistant. The clinical team are supported by a operations manager, business manager, reception manager, practice coordinator and a team of administrative and reception staff.

The practice is open between from 8am to 6:30pm Monday to Friday. The practice offers a range of appointment types including book on the day, telephone consultations, online consultations and advance appointments.

Extended access is provided by the PCN, where late evening and weekend appointments are available. Out of hours services are provided by gtd healthcare.
