# Summary of findings

#### **Overall summary**

Rathmore House is a 'care home'. People in care homes receive accommodation and nursing or personal care as single package under one contractual agreement.

Rathmore House can accommodate up to 20 older people and specifically those who are living with dementia. At the time of our inspection there were 19 people living in the home.

We found the following examples of good practice:

• The home had decided to design and build a small 'pod' structure in the external grounds with infection control considerations built in, such as screening and separate entrances for individual residents and their significant other. This created an opportunity for visiting arrangements to be maintained in line with changing national and local lockdown arrangements. Infection control measures such as cleaning and Personal Protective Equipment (PPE) were also implemented.

• The home had learned from a previous wave one outbreak of COVID-19 and encouraged and embedded a supportive culture, when staff checked and reminded each other during handovers to always wear appropriate PPE and ensure correct donning and doffing, in line with requirements.

# Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.
