Summary of findings

Overall summary

Arrigadeen Nursing Home is a family run care home. It is registered to provide accommodation and nursing care and or personal care for up to 29 people. At the time of our visit there were 13 people living at the home.

We found the following examples of good practice:

•The provider had used space creatively to assist in managing the service safely. There were now two temporary staff rooms. There were changing rooms for male and female staff to use at the start of every shift. There was also one-way access in and out of the home.

• There had been forward planning just before the Pandemic started. This had meant there had been no shortage ever of Personal Protective Equipment (PPE). The provider had invested in a full range of PPE and staff wore full 'scrubs' clothing when supporting people with care. All staff work clothing was washed on the premises at safe temperatures.

• The two directors who run the service, one of whom is also the registered manager, had been working very closely with staff. They were very "hands on" to support the team and keep a very close eye on quality and safety.

• When people had been at risk they were supported in safe well-planned ways. The service ensured people had their own named staff to offer support for all their needs. This included their meals and social support needs.

• Staff had been able to take part in a range of training at a very early stage of the Pandemic. This had really helped them to know and how to support people safely in the home.
