## Summary of findings

#### **Overall summary**

Knoll House is a 'care home' registered to provide accommodation and personal care for up to 22 people.

We found the following examples of good practice.

• People were admitted safely to the service. Each admission was carefully planned, and a 14-day period of isolation was completed by each person.

• Staff were provided with a designated preparation area for their arrival at and departure from the service. Personal Protective Equipment (PPE) donning and doffing spaces were available within each corridor of the service with guidance and signs displayed throughout the building. Staff were seen to be maintaining social distance and adhering to the PPE guidance and protective measures in place.

• The service had been providing 'garden visits' with robust infection control procedures in place. Visits were limited and were by appointment only, with times allocated to avoid potential infection transmission with other visitors. The registered manager was assessing a room within the service with a view to being able to safely facilitate visits in the future which would not be weather dependent.

• Procedures and guidance had been developed by the registered manager which had been successfully implemented at the service.

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.
