# Summary of findings

## Overall summary

Aston House Care Home is a care home for up to 48 older people. At the time of the inspection, 39 people were living at the service. The home is managed and operated by HC-One Limited.

We found the following examples of good practice.

The provider had taken steps to prevent and control the spread of infection. They had reviewed their procedures and practices to help protect people during the COVID-19 pandemic. There were suitable cleaning schedules and systems for managing laundry. The staff, registered manager and provider's representatives carried out regular audits to make sure the environment was clean and safe.

The registered manager worked closely with others to learn and develop best practice. Staff were well informed and understood their roles and responsibilities in keeping people safe from infection. Staff wore personal protective equipment (PPE) such as masks, gloves and aprons.

The provider supported people to stay in touch with family and friends in a safe way. Visitors were required to take COVID-19 tests and wear PPE. The provider supported people to have contact through phone and video calls.

## **Detailed findings**

### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at how services manage infection control and visiting arrangements. This was a targeted inspection looking at the infection prevention and control measures the provider had in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 11 January 2022 and was announced. We gave the service 24 hours' notice of the inspection.

# Is the service safe?

## Our findings

### Staffing

- The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures.

### How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

- The service was meeting the requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
