This was our first assessment of this location since the provider took over the running of the practice in April 2023. We rated the key question of responsive as good. The practice remains unrated overall.

Our inspection team

Our inspection team was led by a CQC inspector who spoke with staff using video conferencing facilities.

Background to Central Lakes Medical Group

Central Lakes Medical Group is located at Rydal Road, Ambleside LA22 9BP. It has a branch surgery at Bragg Field, Hawkshead, LA22 0QW

The provider is registered to deliver the regulated activities of diagnostic and screening procedures; maternity and midwifery services; treatment of disease, disorder or injury; and, surgical procedures.

The practice is situated within the NHS Lancashire and South Cumbria Integrated Care Board (ICB) and delivers a General Medical Services contract (GMS) to a patient population of over 5900 patients. This is part of a contract held with NHS England. The practice is part of a wider Primary Care Network (PCN).

Information published by Office for Health Improvement and Disparities shows that deprivation within the practice population group is on the 9th decile (9 of 10). The lower the decile, the more deprived the practice population is relative to others. The practice population is 97.7% white with the remainder of the population being mixed.

The practice is open between 8am to 6.30pm Monday to Friday The practice offers a range of appointment types including telephone consultations and advance appointments.

Out of hours services are provided by 111 and Cumbria Health On Call.
