#### Why we carried out this inspection

This inspection was a comprehensive inspection which included a site visit. The inspection was carried out following changes to the practice registration in March 2020, after the existing provider changed its legal status and the length of time since its previous inspection in 2018.

#### How we carried out the inspection

Throughout the pandemic CQC has continued to regulate and respond to risk. However, taking into account the circumstances arising as a result of the pandemic, and in order to reduce risk, we have conducted our inspections differently.

This inspection was carried out in a way which enabled us to spend a minimum amount of time on site. This was with consent from the provider and in line with all data protection and information governance requirements.

#### This included:

- Conducting staff interviews using video conferencing
- Using questionnaires sent to staff prior to the on-site visit
- · Completing clinical searches on the practice's patient records system and discussing findings with the provider
- Reviewing patient records to identify issues and clarify actions taken by the provider
- Requesting evidence from the provider
- A shorter site visit

# Background to Droylsden Medical Practice

The practice is part of gtd Healthcare, a not for profit provider of primary care, urgent care and out-of-hours dental services across North West England.

The provider is registered with CQC to deliver the Regulated Activities; diagnostic and screening procedures, maternity and midwifery services and treatment of disease, disorder or injury and surgical procedures.

The practice is situated within the Tameside and Glossop Clinical Commissioning Group (CCG) and delivers Alternative Primary Medical Services (APMS) to a patient population of about 4278. This is part of a contract held with NHS England.

The practice is part of a wider group of GP practices, Denton, Audenshaw and Droylsden primary care network (PCN). PCNs work together with community, mental health, social care, pharmacy, hospital and voluntary services in their local area.

Information published by Public Health England shows that deprivation within the practice population group is in the third lowest decile (three of 10). The lower the decile, the more deprived the practice population is relative to others.

According to the latest available data, the ethnic make-up of the practice area is 2% Asian, 95% White, 1% Black, and 2% Mixed.

The age distribution of the practice population differs from that of local and national averages, for example, there are fewer older patients (11%) registered at the practice compared to England average (17.4%) and a higher than average young population (31%) compared to England average (20%)

There is a team of three GPs, two advanced clinical practitioners, a senior clinical practitioner (practice nurse), a health care assistant and a phlebotomist. The clinical team are supported at the practice by an operations manager, senior administrators and a team of reception/administration staff. The practice also has access to support from the gtd Healthcare head office team, including human resources, medicines management and clinical leadership for guidance and support.

The practice is open between 8am to 6:30pm Monday to Friday. The practice offers a range of appointment types including book on the day, telephone consultations and advance appointments.

Extended access is also provided locally by gtd Healthcare from the neighbourhood hub, where late evening and weekend appointments are available. Out of hours services are also provided by gtd Healthcare.
