## Summary of findings

#### Overall summary

Bings Hall is a residential care home, providing personal and nursing care for up to 17 older people. The service accommodates people across two floors, which has separate adapted facilities. On the day of our inspection there were 15 people living at the service.

We found the following examples of good practice.

The provider carries out testing for people living in the service and the staff as per government guidance. A designated area for testing had been set up. This was close to the reception however, away from residential or living areas.

A new conservatory had been built to expand the shared living area and provide extra space for social distancing.

Person specific risk assessments, were seen at the home. These risk assessments directed staff to care for people who had limited mental capacity, and supported those that could be affected by the impact of personal protective equipment, causing fear and anxiety.

All cleaning and laundry processes were clearly documented and monitored by the registered manager, to ensure compliance with the hygiene and safety measures in place at the home.

Staff members stated they felt safer at Bings Hall than anywhere else due to the infection control measures that had been introduced by the manager in March 2020.

# Bings Hall Detailed findings

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 26 January 2021 and was announced 24 hours before our visit due to lock down visiting restrictions.
