Summary of findings

Overall summary

Trentside Manor Care Home provides accommodation and personal care for up 36 to people in one adapted building. At the time of the inspection, there were 33 people using the service.

We found the following examples of good practice.

- There was a visiting policy in place, which had been shared with relatives. A temporary visiting area had been implemented to enable visits to take place without entering the main building to ensure people remained safe.
- People used technology to continue to have contact with their relatives such as video calls. The registered manager ensured relatives were regularly updated of any changes to their relative's health and wellbeing.
- Staff had continued to provide activities in line with people's preferences to help reduce social isolation and to promote people's mental wellbeing. One person requested a priest who visited the service, followed IPC procedures and wore Personal Protective Equipment (PPE).
- The environment was clean and additional touch point cleaning had been implemented to lower the risk of cross infection.
- Staff were supported by the registered manager during periods of anxiety. There was an open and supportive culture within the staff team and the registered manager was aware of mental health services to signpost staff to if needed.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.
