# Summary of findings

## Overall summary

Grangemoor House Nursing Home is a residential care home providing nursing and personal care for up to 30 people aged 18 and over. At the time of the inspection 23 people were using the service.

We found the following examples of good practice.

- The provider had an outbreak of Coronavirus recently within in the home. The providers management had used zoning effectively in the home to prevent the spread of infection to others living in the home.
- The signs around the home were varied and informative about COVID-19 and handwashing. These were both pictorial and written to be inclusive and accessible for people living in the home.
- There were clear processes and plans in place to admit people safely which followed best practice guidance.
- There was enough PPE for staff, who were seen wearing PPE at all times. There were a number of PPE station around the home.
- Regular testing of staff and residents for COVID-19 was in place and the vaccination programme was in place.

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe, and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.

This inspection took place on 08 February 2021 and was announced.
