## Summary of findings

### **Overall summary**

The White House is a 'care home'. People in care homes receive accommodation and nursing or personal care as single package under one contractual agreement. The Care Quality Commission (CQC) regulates both the premises and the care provided.

The White House is registered with CQC to accommodate up to 28 people and at the time of this inspection, 23 people were accommodated and there were five vacancies.

We found the following examples of good practice.

Staff received specialist Covid-19 infection prevention and control training.

Fixtures, fittings and high-use surfaces were visibly clean.

Policies and procedures for entering the home were effective in protecting against the spread of infection. Processes in place for enabling visits to people who used the service promoted the wellbeing of all concerned.

The emotional wellbeing of staff was supported, and staff reported that senior managers had promoted a caring and open-door culture.

Risk assessments had been completed and action taken to ensure individual needs relating to Covid-19 were met.

# The White House Detailed findings

# Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 10 March 2021 and was announced.

- We were assured that the provider was preventing visitors from catching and spreading infections.

- We were assured that the provider was making sure infection outbreaks were effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
