Summary of findings

Overall summary

Fairway View is a residential care home providing personal care for up to 41 older people. At the time of our visit 29 people were living at Fairway View. All bedrooms were en-suite. There were a variety of communal facilities which included a a sitting room on each floor, a tea room, seating areas around the home and a visitors room.

We found the following examples of good practice:

- People were supported to maintain contact with family members and friends using telephones and video calling. There was a separate visitors' area with a designated entrance so people could visit when it was safe to do so. Visits were currently taking place.
- Staff were observed to wear the correct Personal Protective Equipment (PPE) in line with government guidance. PPE was accessible throughout the service.
- Cleaning schedules had been increased to ensure high touch surfaces such as door handles and light switches were cleaned regularly. Additional cleaning had been introduced to maintain good hygiene standards.
- The service was using the space available to enable people to socially distance. The dining room had been re-designed so people could sit at a safe distance from each other.
- The service had an up to date infection control policy.
- People were safely admitted to the service in line with government guidance.
- Staff supported people to engage in socially distanced activities such as 'nails and natter' watching a film and attending a virtual church service. Staff had put measures in place so people could participate in these events safely.
- People and staff were regularly tested for COVID-19.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.
