Summary of findings

Overall summary

Birkdale Park is registered to provided accommodation, nursing and personal care for up to 36 adults. The home admits older people with general nursing care needs. The service was supporting 34 people at the time of the inspection.

We found the following examples of good practice:

- People were admitted to the service safely. People were tested for COVID-19 prior to and on their arrival and were cared for in their own room for an initial period of ten days.
- A safe visiting procedure was in place and followed. Physical visits to the home were facilitated for people's relatives in line with current guidance including times of exceptional circumstances, such as end of life care.
- The service was registered for regular testing to ensure people and staff were tested frequently. The service also carried out additional testing if people or staff presented with symptoms.
- Policies, procedures and equipment were in place to maintain infection control and support the needs of the people using the service. The service worked in partnership with external professionals such as Infection Control Teams to help implement best practices.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe, and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.
