## Summary of findings

### **Overall summary**

Appleby Court is a care home which can accommodate up to 61 older people who need residential or nursing care across two floors. Communal rooms and dining areas are situated on both floors offering people a choice of areas to use. At the time of our inspection 54 people were living at the service.

We found the following examples of good practice.

The service had updated their policies and procedures to ensure infection prevention and control (IPC) processes were robust. All visitors had their temperatures checked, asked about any COVID-19 symptoms and were required to complete a 'track and trace' form, in order to contact visitors should there be an COVID-19 outbreak after their visit.

Donning and doffing stations were situated in the service and personal protective equipment (PPE) was available throughout the building. Staff had designated areas to change into their uniforms and all staff had received training in IPC and PPE in relation to COVID-19. When agency staff were required, the same staff member was block booked, had their temperature taken and tested for COVID-19 upon arrival to work. People and staff received regular COVID-19 tests.

The service was conducting regular infection control audits, to ensure infection prevention and control (IPC) processes were robust. Cleaning processes had increased throughout the service and cleaning products had been confirmed as suitable to tackle COVID-19. High touch surfaces were regularly cleaned, and checklists were in place.

# Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.
