Background to The Practice South Woodham Ferrers

The Practice South Woodham Ferrers is located in the town of South Woodham Ferrers. The practice is owned by The Practice Surgeries Limited which operates a number of GP practices across the country.

The practice team at The Practice South Woodham Ferrers comprises four GPs, a nurse practitioner, two practice nurses, a healthcare assistant and administrative staff as well as a practice manager.

The practice is open from 8am to 6.30pm on Mondays, Tuesdays, Thursdays and Fridays. On Wednesdays the practice is open from 8am to 8.45pm.

Why we carried out this inspection

We carried out this inspection to check the processes in place for the recruitment of staff only.

How we carried out this inspection

We informed the practice the day before our visit that we would be carrying out an inspection on 13 February 2015.

During our visit we spoke with the practice manager and head of human resources. We reviewed recruitment policies and procedures, and checked the files of newly recruited staff.

Our findings

Staffing and recruitment

The records we looked at contained evidence that appropriate recruitment checks had been undertaken prior to employment. For example, proof of identification, references, qualifications, registration with the appropriate professional body and criminal records checks through the Disclosure and Barring Service (DBS). The practice had a

recruitment policy, dated January 2014, that set out the standards it followed when recruiting clinical and non-clinical staff. The practice also had a recruitment policy for the recruitment of locum GPs. This policy included ensuring appropriate checks had been undertaken. At the time of our inspection The Practice Surgeries Limited, the owner of The Practice South Woodham Ferrers, was in the process of further reviewing and strengthening its recruitment policies and procedures.
