Summary of findings

Overall summary

Sunnymeade is registered to provide care and accommodation to up to 50 people. The home specialises in the care of older people. At the time of the inspection there were 39 people living at the home.

We found the following examples of good practice.

Staff were following good infection prevention and control practices which helped to minimise risks to people.

Staff assisted people to keep in touch with friends and family. Each person who lived at the home had an individual plan and consent form for how they wished to keep in touch with their loved ones. This included using video calls, garden and window visits. The provider had set aside a room which visitors could access without going through the building and had also ordered a visiting pod. This meant people would be able to see visitors in comfort in the colder weather.

Staff continued to support people to take part in activities. Activities were now arranged for small groups and included board games, video calls and celebrating special occasions.

The registered manager was communicating regularly with people, staff and family members to make sure they were all familiar with up to date guidance and practice. One member of staff said, "One thing that has really improved is communication. We all know what's what."
