# Summary of findings

### Overall summary

Elmhurst is a residential care home providing accommodation and personal care for up to 20 people. At the time of the inspection there were 20 people living at the home.

We found the following examples of good practice.

There have been no positive cases of COVID-19 during the pandemic.

When we visited the service was closed to visitors due to enhanced local COVID-19 restrictions. Plans were in place to support safe visiting when the government guidance changed.

Tests for COVID-19 were carried out weekly for staff and monthly for people living at the service. Temperature checks were completed twice daily for staff and people.

The home was clean and there were no malodours. The provider had invested in new cleaning equipment, sensor activated soap dispensers, flooring and dining furniture to ensure high standards were maintained.

Staff had completed training in infection control and donning and doffing personal protective equipment (PPE). They were frequently briefed about changes in government advice.

The registered manager promoted a culture of ongoing learning and improvement. Regular residents' meetings had been held with people to share information. Surveys had been sent to relatives and staff to get feedback about how the home had managed throughout the pandemic. The feedback was positive.

### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.
