## Summary of findings

#### Overall summary

King Edward Care Home provides accommodation for up to 13 older people, including people living with dementia. At the time of the inspection 13 people lived at the home.

We found the following examples of good practice.

The provider had robust practices to reduce risks to people, staff and visitors from catching and spreading infection. Staff were trained on infection prevention and control. They completed frequent and thorough cleaning routines to reduce infection risks and kept the environment clean and hygienic. There was enough PPE for staff and any visitors. Staff were familiar with policies and procedures and Information about COVID-19.

People kept in touch with families by phone, emails and social media as well as visits. The provider had a new extension built to assist people's friends, family and professionals to have socially distanced visits. The room was fitted with a hand washbasin and PPE and thoroughly cleaned between visits. All visitors were asked to complete a health screening form, have their temperature checked, take a COVID-19 test, wash and sanitise hands and were provided with PPE to wear throughout their visit. People and their relatives were praising of the staff, the care they provided, cleanliness of the home and infection control practices.

Senior staff completed risk assessments on and with each person supported and each staff member. These showed their specific needs in relation to COVID-19. People supported and staff were taking part in regular COVID-19 testing and had all been vaccinated against COVID-19. Any admission was expected to follow Public Health England guidance.
