## Summary of this inspection

#### **Background to Richard House Childrens Hospice**

Richard House is an independent childrens' hospice that provides specialist care for babies, children and young adults who have life limiting, life threatening or complex health conditions. They provide end of life care, step-down care, respite care and post bereavement services. They are provided through residential and hospice at home services.

### How we carried out this inspection

We visited the service and met with the director of family and care services. We reviewed documents that related to the running of the service including individual risk and safety assessments, policies and service contracts. We observed safety checks taking place on equipment.

#### **Environment and equipment**

The design, maintenance and use of facilities, premises and equipment kept people safe. Mixer taps were in place throughout and regulated hot water temperatures at 37.5 degrees maximum. Scoop temperature thermometers were available in every room and used to check safe temperatures at the point of use. Temperatures were recorded on the repositioning and rounding charts. All tap and shower temperatures were additionally tested each morning. A safe bathing policy covered temperature testing and ideal temperatures were noted in the policy.

#### Assessing and responding to patient risk

Staff completed and updated risk and safety assessments for each child. They were sufficiently detailed and reviewed regularly. Assessments and care plans identified different components of care. There were 27 potential assessments such as airways, pain, mobility, outings, consent and skin integrity. A clinical risk management policy was in place and a clinical records audit checked on the quality of assessments. These were reviewed at the clinical governance and quality monitoring committee.
