### Summary of findings

#### Overall summary

Brooklands Care Home is a care home providing personal and nursing care for up to 63 older or younger adults some of whom may have a physical disability or are living with dementia. It is a purpose-built home with lift and stair access to the first floor, accommodation consists of single occupancy rooms situated over two floors. There were 39 people residing at the service on the day of the inspection.

We found the following examples of good practice.

- Dedicated changing rooms were available for staff to use at the start and end of their shift to prevent cross contamination.
- Agency staffs' COVID 19 test results were requested from the agency they worked for and they also took part in the homes testing schedule.
- A new external door was in the process of being fitted to support visitors to undertake indoor visits safely.
- A designated washing machine was used exclusively for the clothing of residents who have tested positive for COVID 19.
- The registered manager completed a protection and prevention plan daily to identify any risks and the actions taken to mitigate risks.

**Detailed findings** 

#### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.

This inspection took place on 27 November and was announced.
