Summary of findings

Overall summary

Cottingham Road is a residential care home providing personal care to four people at the time of the inspection. The service can support up to four people and specialises in providing care to people with a learning disability and autistic people.

We found the following examples of good practice

Professionals were required to provide evidence of their testing and vaccination status. We were assured the service was following current Government guidance on visiting arrangements.

There were plentiful supplies of personal protective equipment (PPE) throughout the home which included gloves, masks and aprons.

There were areas around the home close to bedrooms where PPE stations could be located if people were required to isolate.

The manager was aware how to use isolation, cohorting and zoning to manage any potential spread of infection.

Staff participated in a daily testing regime prior to commencing work. We saw various cleaning records which included regular high touch point cleaning to ensure the potential for cross infection had been reduced.

Policies, procedures and risk assessments related to COVID-19 were up to date which supported staff in keep people safe.

Staff had completed training in relation to infection control, and regularly receive refresher training about the correct use of PPE including donning and doffing. The manager was using spot checks to ensure staff adhered to their original training.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 (the Act) as part of our regulatory functions. We checked whether the provider was meeting the legal requirements and regulations associated with the Act. We looked at the overall quality of the service and provided a rating for the service under the Care Act 2014.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 2 March 2022 and was announced. We gave the service 24 hours notice of the inspection.

Our findings

Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider's infection prevention and control policy was up to date.
- We have also signposted the provider to resources to develop their approach.

Visiting in care homes

• The provider followed the current government's guidance to facilitate visits safely. During the active COVID-19 outbreak people were supported to stay in touch with their relatives via video and phone calls.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
