# Summary of findings

### Overall summary

St Marks Nursing Home is a 'care home.' The service provides accommodation for up to 35 people with personal care needs, some of whom were living with dementia. On the day of our inspection 31 people lived at the service.

We found the following examples of good practice.

Staff had completed IPC training, with further training being planned. The provider had good supplies of PPE and staff used this correctly. The provider had improved IPC practices following a recent external inspection.

The home was clean and tidy throughout. Staff maintained enhanced cleaning practices to help manage infections.

There were no restrictions on visiting the home. Face mask wearing was encouraged in communal areas.

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 31 October 2022 and was unannounced.
