Summary of findings

Overall summary

Redwell Hills Care Home is a care home providing nursing and residential care for up to 50 people, some of whom are living with dementia. At the time of this inspection there were 22 people living at the home. People have their own rooms with en-suite facilities and access to a range of communal areas. The home is built over two floors.

We found the following examples of good practice.

- All staff and visitors had to wear appropriate personal protective equipment (PPE), complete a health declaration form, NHS Track and Trace information and had their temperature checked prior to entering the home. Additional cleaning of all areas and frequent touch surfaces was being carried out and recorded by housekeeping staff.
- Staff supported people's social and emotional wellbeing. The service had used different methods including information technology to assist communication with staff wearing face masks. The provider and staff kept family members up to date about the latest guidance and their relative's health via regular telephone calls, letters and social media.
- All staff, including catering and housekeeping staff had undertaken additional training in infection prevention and control. This included putting on and taking off PPE, hand hygiene and other Covid-19 related training.
- The manager explained the quality systems they had in place to check the service was providing safe care. There was a robust communication system on place to ensure staff received consistent updates in relation to infection control policy and practice.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.
