Summary of findings

Overall summary

The Granary is 'care home' registered to provide accommodation and support for up to 12 adults who may have a learning disability or autistic spectrum disorder. At the time of the inspection there was 11 people living in the home.

We found the following examples of good practice.

• Staff were wearing PPE in line with government guidance and designated areas were set up within the service for staff to remove and apply PPE. Staff supported people to wear PPE when going out into the community.

• The service had signage displayed on all external doors to alert visitors to restrictions on entering the building and the infection control measures they would need to take. Sanitising hand gel and disposable face masks were provided.

• Staff and people who used the service were tested for Covid-19; latest swabs showed everyone tested negative.

• The service communicated with relatives to promote people's wellbeing. Staff were in regular contact with relatives. People were supported to take regular exercise and join in activities to maintain their wellbeing.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.

This inspection took place on 19 August 2020 and was announced. The service was selected to take part in this thematic review which is seeking to identify examples of good practice in infection prevention and control.
