## Summary of findings

#### **Overall summary**

Tudor Lodge is a service registered to provide accommodation, personal care and nursing for up to 82 older people, some of whom may be living with dementia. There were seven designated beds for people receiving end of life care. The building offered accommodation over two floors with lift access to each floor. People have access to communal lounge and dining areas, an accessible garden and outside space. There were 63 people living at the home at the time of inspection.

We found the following examples of good practice.

• Polices and procedures in relation to infection control were thorough and up to date.

• There were arrangements in place to allow relatives and external professionals to safely visit the home.

• Staff received relevant infection prevention and control training and adhered to good practice around using personal protective equipment.

• Measures were in place to allow isolation, zoning and cohorting should it be required.

• Appropriate infection prevention and control arrangements were in place, including a designated policy, for people receiving end of life care.

We were assured that this service met good infection prevention and control guidelines.

# Tudor Lodge Nursing Home Detailed findings

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at how services manage infection control and visiting arrangements. This was a targeted inspection looking at the infection prevention and control measures the provider had in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 13 January 2022 and was announced. We gave the service 24 hours notice of the inspection.

## Our findings

Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The service was meeting the requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
