## Summary of findings

#### **Overall summary**

Box Tree Cottage is a 'care home' and is registered to provide accommodation and personal care for up to 14 people. At the time of the inspection there were 14 people living in the home.

We found the following examples of good practice.

On arrival at the home visitors were asked to complete a test for COVID-19. They were also were required to wash their hands and were given personal protective equipment (PPE) to put on.

The home had an ample supply of PPE. All staff had received training in the correct use of PPE, and how to take it off and put it on safely. Staff had worked flexibly to change shifts and work extra hours so that there was no need to use agency staff. Because of the size of the home it was difficult to implement social distancing for people living there. However outside areas were being used for staff breaks and meetings to enable social distancing for staff.

People were supported to have regular contact with their families and friends via video calling. People were supported to take part in activities that they enjoyed with staff.

Testing was carried out for both people living in the home and staff on a regular basis. If anyone had symptoms of COVID-19 they were tested immediately.

Cleaning of the home, including frequently touched surfaces, had increased to reduce the risk of transmission of infection. There were ample supplies of cleaning equipment. Staff had been made aware of the correct cleaning fluids to use to prevent the spread of infection. Uniforms including shoes had been purchased for all staff. Staff changed into their uniform at the start of each shift. They then changed out of the uniform at the end of their shift and this was washed in the home.

# Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 02 March 2021 and was announced. The inspection was announced prior to us entering the home, so we could ensure that measures were in place to support an inspection and manage any infection control risks.

# Our findings

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.

• We were somewhat assured that the provider was admitting people safely to the service. The registered manager stated that they were not following the government guidance and assessing people's temperatures twice a day to help identify early signs of infection. We have also signposted the provider to resources to develop their approach.

- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
