## Summary of findings

#### Overall summary

Hopton Cottage Care Home is a purpose-built care home, predominantly ground floor, with 62 bedrooms. It provides accommodation and personal care to those over 65, some of whom may be living with dementia. At the time of the inspection 51 people were using the service.

We found the following examples of good practice.

Donning and doffing stations were situated in the service and personal protective equipment (PPE) was available throughout the building. All staff had received training in IPC and PPE in relation to COVID-19.

A bedroom with external patio doors had been converted into a visiting room early in the pandemic to facilitate safe visits when permitted. People were also supported to maintain regular contact with friends and family through video calls, telephone calls and visits at the window.

People we spoke with and staff told us they felt safe and were well supported. Numerous activities had taken place in the home and garden whilst people were shielding to maintain physical and emotional wellbeing.

A robust process was in place for professional visits. All visitors had their temperatures checked and were required to complete a lateral flow test if it was essential they entered the building. People and staff received regular COVID-19 tests.

The service conducted regular environmental audits, as well as observations of staff PPE use and hand washing, to ensure infection prevention and control (IPC) processes were robust.

The home was very clean and cleaning processes had increased throughout the service including high touch surfaces.

**Detailed findings** 

#### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.

This inspection took place on 9 March 2021 and was announced.
