Summary of findings

Overall summary

Heathside Neurodisability Unit is a care home with nursing, providing support, accommodation and rehabilitation for up to 18 people. The home specialises in providing rehabilitation for people with a brain injury and/or progressive neurological conditions. At the time of the inspection 18 people were using the service

We found the following examples of good practice.

There was a clear system in place to ensure all visitors adhered to best practice guidelines when entering the service.

Measures such as isolation and cohorting of exposed and unexposed people have been risk assessed and there were workable plans in place.

People have been tested for COVID-19 by the hospital and from the community before they were admitted to the service.

Clinically trained staff delivered infection control training and staff knowledge and understanding was continually checked and refreshed.

The service has a designated lead for cleaning and infection control within the service. Cleaning schedules had increased to reduce the risk of infections being spread on high touch areas such as door handles and light switches.

The provider had assessed the risks to staff including those associated with ethnicity, age, health conditions. The provider had also considered the risks of staff travelling on public transport and had made adjustments to help mitigate these risks.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.
